Responsibility for the policy

Firefly International's Board of Trustees is ultimately responsible for the adherence to this policy.

The director and charity manager will evaluate donations, grants and any other sources of income or benefit in kind in line with our policy.

Should any concern arise in relation to an evaluation then the matter will be raised with the Trustees. Any decision to accept, reject or return funds will be made by Trustees on a consensus basis.

Evaluation and acceptance process

Where there is any concerns about a source of funds, or where a donation or grant is material to the charity's income (i.e. 10%+) then the director or a trustee is to conduct an evaluation in writing.

The evaluation should look at whether the source and any stipulations around the use of the resources fits with each of our values in turn.

In exceptional circumstances the Trustees may wish to seek advice from OSCR – our regulator – and or a legal professional.



Considerations for evaluating potential or raised funds against our policy

| Child centric | Is the funder involved in activities that harm children? Examples include the weapons trade, pornography and sale of harmful substances. | Are the funds being used to help children affected by war? |
| Locally led | Does the funder behave in a way that looks to be controlling / requiring? | Are there any stipulations or restrictions re the use of funds which are at variance / not supportive of the local team's vision or purpose? Does the local team support the project / funding use? |
| For the long-term | Is there a risk to Firefly's reputation from working with the organisation? | Could the project undermine the long-term nature of our work? |
| Kindness | Has the organisation been involved in illegal activities? | Any misgivings? |

| Professionalism | Is the organisation involved in activities that while legal are not ethical? Examples might include the gambling sector. | Any poor treatment / lack of respect for our team in the UK or our overseas teams? |
